MICHAEL J. RYAN 2022 Recipient

RTL EDUCATIONAL FOUNDATION OF KY AWARD

Michael J. Ryan was born in Vincennes, IN and graduated from Jeffersonville High School in 1957. He began a co-op at the Colgate Palmolive Co. while attending the University of Cincinnati. Mike obtained his degree in Chemical Engineering in 1962 plus a commission as a 2nd Lieutenant in the U.S. Army Ordnance Corps then went to work at Colgate. Six months later he was called up for active duty and volunteered for an Explosive Ordnance Command. After 19 weeks of conventual and nuclear weapons training he was assigned as the commander of the 71st Ordnance Detachment (Explosive Disposal) at Fort Hayes, OH. The unit received numerous commendations.

Mike was discharged as a captain from the Army in the summer of 1966. He returned to Colgate's Jeff Plant where he was promoted to various engineering and production leadership positions throughout the Colgate Company. Mike retired at the age of 55 after 36 years with the Colgate Co.

During retirement in Kansas Mike pursued the game of golf with earnest until his wife said, "You are not going to just play golf, you are going to do something of more importance." So she took Mike to a Respect Life meeting at their parish. While there, he heard about abortion and a report from a lady and her 11-year-old daughter that while praying at an abortion clinic in Wichita, KS they had to wear a jacket even in July because the evil made it so cold. Mike said, "What is this? This can't be! This abortion is wrong!" The rest, as they say, is history.

In 1997 Mike made a presentation to the Louisville Right to Life Board of Directors with a somewhat different approach to the traditional golf outing. The Board liked it and asked Mike to join the Board – he agreed. Mike has been a member of the Right to Life of Louisville Board for 24 years, serving as Chairman or Co-Chairman of the golf outing for 21 years. The total funds raised for the 21 years is \$775,000, meant for use by the Right to Life Educational Foundation of Kentucky. Mike has also served as President and Vice President of Right to Life of Louisville and Treasurer of Kentucky Right to Life and has worked on many projects for Kentucky Right to Life.

Mike has been married to his wife Glenda for 53 years and they have three children, 10 grandchildren (two in heaven). He is a member of St. Margaret Mary Parish and Knights of Columbus Council 15979 at the parish. He holds the office of Advocate and Culture of Life.

Dr. Albert J. Schweitzer humanitarian of the year award

Monica Henderson is a Louisville native, and since January 2009 has served as the Executive Director of BsideU for Life Pregnancy & Life Skills Center (formerly A Woman's Choice Resource Center & Necole's Place). She received her bachelor's degree from Furman University in Greenville, South Carolina. She also studied historic preservation planning from Cornell University.

Monica worked in government as a preservation analyst, after which she attended law school, graduating in 1998 as co-salutatorian from the University of Louisville Brandeis School of Law. She served as a law clerk for Federal District Judge John Heyburn for one year, and then practiced law at Stites & Harbison for nine years in commercial real estate and conservation easement & land trust law. While there, she also represented and advised several nonprofits. She's served on several nonprofit boards, including the Brandeis School of Law Alumni Council, the Board of NAMI Kentucky, the Board of Preservation Louisville, the board of Access Justice (formerly Metro Christian Legal Aid) and the board of trustees for her former church, Little Flock Baptist Church. She currently serves on the finance committee of her current church, Highview Baptist Church.

Monica also serves as a Care Net Center Services Specialist, providing advice and encouragement to pregnancy center directors around the country on matters related to personnel, legal, and operations issues.

Monica is a member of Highview Baptist Church, and has been married to her husband Todd since 1992. They are empty nesters with two adult sons – one who lives in Indianapolis, and one who attends the University of Louisville.

Changing Hearts Saving Lives PROLIFE ADVOCATE OF THE YEAR

Amanda and her husband Whitney have been married for 12 years and have two beautiful children through the gifts of adoption and embryo adoption. They were drawn to the work of their local pregnancy center several years ago. Amanda feels they are just a small part in the work God is doing to save lives.

Amanda has severed as Director of The Alpha Alternative Pregnancy Care Center located in Hopkinsville since 2016. The Center provides mentoring, resources, parenting classes, and other services to over 500 women every year who may be considering abortion. Their goal is to glorify God in all they do and seek His will for the Center.

In the last 5 years, Amanda has witnessed over 100 women change their minds and choose life for their babies after seeing an ultrasound.

Kentucky Right to Life asked Amanda's Center Staff to share a bit about Amanda;

"As one of the nurses at Alpha Pregnancy Care Center, I have had the privilege of working beside her in ministry and have witnessed the compassion and Christ-like love with which she lives and works. First and foremost, she loves the Lord. She actively seeks ways to spread the gospel. I've seen her share her faith on multiple occasions. She shows genuine love and concern for each patient and family who comes through our door. She often goes out of her way to meet individual needs. She is an incredible leader who invests in each employee, encouraging them to step out of their comfort zone and find ways to use their own gifts and abilities to expand the reach of the ministry. She makes each one of us a better person because she lives by example. I speak for our entire staff when I say we are so thankful for her".

Kentucky Right to Life, Changing Hearts - Saving Lives ProLife Advocate of the Year is presented in recognition of an individual who has a heart inspired by God to see the beauty of each life as a Gift from God. Their strength of conviction to extend a helping hand and their heart to love beyond measure recognizing the dignity and potential of every life are a reflection of Kentucky Right to Life's own mission and ministry. It is bestowed in honor of their significant personal or professional contributions, demonstrated through their dedication to pro-life activities and their unwavering respect for the most vulnerable in our midst, especially the unborn child and their mothers.

The Kentucky Right to Life Changing Heart ~ Saving Lives Award is inspired by the tradition of the 'Red Rose ~ White Rose'

You may be familiar with the Red Rose as a symbol of the pro-life movement's respect for the lives of preborn babies and their mothers. But are you aware of the history of the White Rose?

By the mid-1930s, ending the lives of those deemed physically or socially unfit was openly accepted in Germany. By 1939 the "mercy killing" of babies born with abnormalities, the elderly, the chronically or incurably ill, the mentally ill, and the physically or mentally disabled was officially legal.

Hans Scholl, a young medical student, in Germany in the 1941, is said to have heard a sermon on this "terrible thing"- the government sanctioned killing of innocent people. Scholl and a group of students then formed the Weisse Rose (White Rose). Using a small duplicating machine, the students distributed thousands of pamphlets denouncing the Nazi regime and its crimes against life.

The son of a pregnancy resource center director, Seth Gruber was raised in the prolife movement and has been speaking publicly on behalf of unborn children since the age of 19. He has spoken across the U.S. educating and equipping pro-life advocates to be a gracious and persuasive voice for unborn children.

Seth travels and speaks in Protestant and Catholic high schools, churches, pro-life training seminars, and for pregnancy resource center banquets, engages in academic debate, and blogs and writes as cultural and political commentator. Seth is also the host of the podcast UnAborted!

First gaining exposure during his college years, Seth founded and directed the Students for Life Club at Westmont College, a Christian liberal arts institution. While there, he conducted educational displays on campus to challenge the institution for their refusal to take a formal position on abortion. During his summers between college, Seth worked as an intern with The Center for Bio-Ethical Reform in Southern California, where he helped coordinate and conduct the Genocide Awareness Project at over 10 universities and was equipped how to engage the issue of abortion with both boldness and grace. Upon graduation, Seth joined Life Training Institute as a pro-life speaker and commentator. He is now a nationally renowned speaker for life and is represented by the Ambassadors Speaker Bureau.

Seth has been featured by World Magazine, American Family Association (AFA), Christian Research Institute, Christianity Today, Life Site News, Students for Life of America, Christian Research Network, and National Radio Broadcasts. He writes regularly for Christian Research Institute and his own personal blog.

A compelling and passionate voice for the unborn, Seth Gruber is reaching all generations and is helping change the way that our country thinks about and interacts with abortion.

Position Statement ABORTION EXCEPTIONS

Right to Life restates unequivocally that it is opposed to all abortion and respects all human life from fertilization to birth to natural death. Abortion destroys an innocent life.

If the rare situation arises when a mother's life is endangered, then her physician/ obstetrician should do all he or she can to save both the life of the mother and the life of her unborn child.

Pregnancies from rape, which are rare, and incest are not reasons for allowing abortion. Abortion in cases of incest hides the crime of incest, which continues to hold the female victim in bondage to the secrecy of the molestation.

If pregnancy results from rape or incest, the woman should be given the support she needs to carry her pregnancy to term, have the baby, and, if unable to care for the child herself, then place the baby in the loving arms of adoptive parents.

Though some may say it is a grave injustice to ask a woman who conceives through rape to bear a child she does not want, it is an even greater injustice to destroy an innocent human life. We believe that all lives are precious in God's eyes regardless of the circumstances surrounding his/her conception. To do violence to the unborn child will not undo the violence already done to the mother.

The woman, who has been violently attacked, should be given medical attention, love, and support in the wake of this trauma and not be prompted to undergo additional trauma from abortion, which has its own physical and emotional complications.

To allow abortion as an acceptable medical procedure and a solution to a social problem would result in no logical barrier to abortion on demand. Only by finding positive solutions to unplanned pregnancies will we truly foster a life-affirming culture in our world today and in the future.



PROMOTING THE DIGNITY AND VALUE OF INDIVIDUALS WITH DOWN SYNDROME!

Right to Life has successfully advocated for the following legislation in Kentucky:

- 1. State Funding (1978) No state funds to be used for abortion
- 2. Insurance Coverage (1978) No insurance policies cover abortion except by payment of additional premium
- 3. Use of Public Facilities (1980) No public facilities to be used for abortion
- 4. Public Funding (1980) No public funds to be used for abortion
- 5. Agency Regulations (1978) Penalties for any agency receiving kickback fees for abortion referrals
- 6. Informed Consent for pregnant women (1984) (Enjoined in Eubanks v. Brown (1984)
- 7. Parental-Judicial Consent (1986) Requires minor seeking abortion to receive consent from parent, or in limited circumstances, a judge
- 8. Defeat of Living Will (1976-1988) (Unfortunately, Kentucky now has a Living Will and Health Care Directive Law) Defeat of amendment to remove food and hydration provision from Living Will (1992)
- 9. Parental-Judicial Consent (1994)
- 10. Anti-Assisted Suicide (1994) Prohibits assisted suicide or euthanasia
- Informed Consent (1998) (A Woman's Right to Know) Requires that the abortionist offer complete information about patient risk, fetal development and alternatives to abortion, and requires a 24-hour period of reflection before procuring abortion
- 12. Abortion Clinic Regulations (1998) Requires that minimum standards be maintained in the performance of abortion
- 13. Partial-Birth Abortion Ban (1998) Struck down by Sixth Circuit Court of Appeals
- 14. Fetal Homicide (2004) Considers a baby in utero from conception onward to be second victim in any criminal homicide that harms or kills the unborn child
- Amendment to 1998 Informed Consent Law (2016) Mandates a face-to-face meeting with a physician, or a health care professional whom he delegates, at least 24-hours prior to the abortion. This eliminates the telephonic pre-recorded message that had been used since 1998.
- 16. Ultrasound informed consent (2017) Requires abortion providers to perform, display, and explain an obstetric ultrasound prior to a woman consenting to abortion in Kentucky.
- 17. Pain Capable Unborn Child Protection Act (2017) Prohibits abortion past 20-weeks gestation to protect unborn children from feeling excruciating pain during the procedure.
- Defunding Planned Parenthood (2017) Prohibits use of local or state tax-payer funds for abortion, and redirects federal tax money away from organizations that perform abortions and prioritizes funding to health agencies that do not.
- 19. Protecting Unborn Children from Dismemberment Abortion (2018)
- 20. Web-Cam Abortions Prohibited (2018)
- 21. Clarification of definitions used in legislation, including abortions and abortion reporting (2020)
- 22. Born Alive Bill, providing for treatment of any infant born alive, including after a failed abortion (2021)


